Bids must be valid for a period of **90 days** after bid opening and must be accompanied by original copy of the bid security amounting to a minimum of **Rs2 00000/-** which shall be valid for 30 days beyond the validity period of the bid (i.e. **120 days**). If the bidders choose to deposit bid security in cash, then a original copy of deposit voucher of above mentioned amount in bank account as specified below, must be submitted by the bidder along with the bid.


